Regular Board Meeting
March 8, 2019 @7 pm
Price County Extension Office

Peter Dahlie, Christine McMillan, Wyatt Lebal, Virginia McMillan, Brooke Lebal, Deb Urbanik, and Paul Dischler were excused, we had to change our monthly meeting from Sunday to Friday because of the weather.

Meeting was called to order by Drobnik at 7 pm.

Minutes: A motion was made by Hardginski, seconded by Nordall to approve the minutes from our February 17, 2019 meeting. Motion passed.

Public Comments & Correspondence: No report

Building & Grounds employee: After some misunderstanding from our last meeting, Brokl will look over the maintenance ad, make some changes, and get it out to a few of the board members before sending it to the Review newspaper and our web-site. The deadline to apply will be April 3 and hope to have someone hired by April 20 or 27.

On Friday, March 22 after 8 am to have as many people that can help out to bake/process the pastries and Drobnik will get the help to work at the booth on Saturday & Sunday.
